Plastic Pollution and Recycling Modernization Act



- Effective Jan. 1, 2023
- Includes updates to Oregon's recycling system
- Aimed at reducing social and environmental impacts of covered products (packaging, printed paper, and food serviceware)



Oregon Impact Reduction and Reuse Program

Under ORS 459A.941:

 "DEQ shall establish a program to reduce the environmental impacts of covered products through means other than waste recovery, including waste prevention and reuse."

Limited to covered products





Timeline

Rulemaking #2

Anticipated timeline: September 2023 concept, 2024 proposal to EQC which will establish fee

Start Rule concept Develop draft implementation development and rules; proposal to Implementation of Oregon Impact initial EQC; fee **Planning** Reduction and consultations established Reuse Program 2024 **July 2026** 2023 2024-2026



Criteria

Funds must be used to reduce the impacts of covered products (packaging, printing and writing paper, and food serviceware) through means other than recycling.

DEQ may:


- Enter into agreements
- Provide grants or loans
- Must consider environmental benefits, human health benefits, social and economic benefits, cost-effectiveness, and needs of economically distressed or underserved communities.
