About rules and the rulemaking process



Rules are agency regulations, carry the power of the law.



DEQ uses the rulemaking process to clarify and implement state law.



Rules are proposed by DEQ and are adopted by the Environmental Quality Commission.

Role of the rulemaking advisory committee

This is an advisory committee

Your ideas inform the proposed rulemaking

Meetings stay focused on proposed rule concepts

Statute guides issues DEQ addresses in this rulemaking

RAC has particular responsibility to review and advise on:

- racial equity impacts of rules
- fiscal impacts of rules



Introduction

- The Mattress Stewardship Act (2022) creates a statewide system for collection & management of discarded mattresses.
- A stewardship organization (SO) must submit a program plan to DEQ by October 1, 2023.
- After program plan is approved, the SO must enroll producers and implement the program on their behalf.

How will the program work?

Retailers collect a flat fee at point of sale



- Eligible entities will access a convenient collection network to get rid of unwanted mattresses.
- Fee goes to stewardship organization to fund operations of program.


Levels of Detail

- Statute establishes requirements (set by Legislature)
- Administrative rules are more specific (adopted by Environmental Quality Commission)
- Program plans include operational details (approved by DEQ)


Plan Review Process

- Review by DEQ
- Review by Mattress Stewardship Program Advisory Committee (MSPAC).
 - Local government, solid waste industry, environmental community, the public
- Public comment period
- DEQ approves, rejects or requests more information

Mattress Stewardship Act (SB 1576, 2022) Rulemaking Advisory Committee Meeting 1

Background

The Mattress Stewardship Rulemaking Advisory Committee will provide input to the Department of Environmental Quality on proposed rulemaking. DEQ is undertaking rulemaking to clarify and implement Senate Bill 1576 (2022), also known as the <u>Mattress Stewardship Act</u>. The Act requires mattress producers to join a stewardship organization with an approved plan to develop, implement and administer a statewide program for the financing, collection and environmentally sound management of discarded mattresses in the state of Oregon.

Rule concepts for discussion at Dec. 8, 2022 RAC meeting

Rule Concept – Annual Fee

DEQ is required by law to establish an annual fee to be paid by the stewardship organization that is reasonably calculated to cover DEQ's costs to administer, implement and enforce the Act.

Rule Concept – Annual Fee

DEQ proposes:

- First year (2024): \$215,000
- Second year: \$190,000
- Third year and onward: \$160,000

Rule Concept – Annual Fee

DEQ welcomes feedback, especially regarding the split of start up costs between years one and two.

- First year (2024): \$215,000
- Second year: \$190,000
- Third year and onward: \$160,000

Rule Concept – Annual Reporting

Background info

A stewardship organization is already required to include certain information in their annual report:

- Program cost and revenue
- Number and tonnage of total mattresses collected, recycled and renovated
- Summary of public education offered in previous year
 (See full list in section 9)

Rule Concept – Annual Reporting

DEQ recommends reporting on reuse:

- Requiring the stewardship organization to report on weights and number of mattresses sent to reuse facilities
- Clarifying that the phrase 'any other facilities' includes reuse facilities

Rule Concept – Annual Reporting

DEQ welcomes discussion and feedback regarding

- mattress reuse
- other items for reporting, including
 - other types of facilities

Rule Concept – Notification of Changes

Background info

A stewardship organization is already required to notify DEQ when there are changes to:

- Location, number of permanent collection sites
- Producers, renovators registered
- Recyclers, renovators that manage mattresses

Rule Concept – Notification of Changes

DEQ recommends that changes in the following entities are cause for written notification:

- Retailers registered
- Reuse facilities managing discarded mattresses



Rule Concept – Notification of Changes

DEQ welcomes feedback about this concept to clarify items required for notification:

- Written notification to be required regarding changes to
 - retailers registered in the program
 - reuse facilities managing discarded mattresses
- Other items for notification
