The Underground Storage Tank Compliance Program has scanned and uploaded all of its paper files having to do with active and recently decommissioned UST facilities. For facilities decommissioned before 2021, the files are not yet online, and must be requested through DEQ's [Public Records Request portal](#).

Search Form

ORMS is a records management solution that provides public access to a variety of records from any jurisdiction in Oregon that chooses to participate. The default search includes all jurisdictions. Searching by Facility ID

The most efficient way to find records for a particular UST facility is to search using the DEQ-issued facility ID number.

1. Choose "Department of Environmental Storage Tanks, Underground Storage Tanks" from the SELECT JURISDICTION menu. **Important: If you do not select this, your search will return records from other departments and agencies.**

3. In the text field next to the menu, enter the UST Facility ID number. There are 2 important requirements:
 - a. You must add leading zeros to make the number 5 digits long. (So "01234", not just "1234.")

- b. You must type an asterisk before and after the number (*01234*)

Searching by address, facility name or county

If you don't know the DEQ-issued facility ID number, you can search by the street address, the county, or the facility name.

Searching by address

If you know the street address of the UST facility, follow these steps:

- Choose “Department of Environmental Storage Tanks, Underground Storage Tanks” from the SELECT JURISDICTION menu. **Important: If you do not select this, your search will return records from other departments and agencies.**

- Click the record you are interested in, and then the blue View/Download button to look at it in your browser, or download it to you own computer.

Searching by facility name

This is not the best way to find a particular facility. The facility name associated with the UST records available online is the one that was current in 2021. You cannot search for either very old facility names, or the new

names of facilities that have changed hands since 2021. Follow the steps above, but type in the facility name instead of the address in step 3.

Searching for “Texaco” returns all of the facilities that had “Texaco” in their name in 2021.

Report Template or Generic Document? Generally, if your document is long enough to need a table of contents, it should use the report template.

Searching by county

If you’re interested in knowing what regulated UST facilities are in each county, you can search by county name. Obviously, populous counties like Multnomah or Marion will return many more results. Follow the above steps, but type in the county name in step 3.
